



GERMAN PACKAGING ACT

Information according to § 15(1) clause 5 Packaging Act for end consumers to whom we hand over packaging:

According to the packaging act, manufacturers, and distributors downstream in the supply chain are obliged to take back packaging that is not subject to system participation within the meaning of section 15(1) clause 1 of the packaging act and to ensure that it is reused or recycled.

The following packages are covered by this:

- Transport packaging
- Sales and outer packaging that does not typically occur as waste from private end consumers after use
- Sales and outer packaging for which system participation is not possible due to harmful substances and/or health risks during recycling
- Sales packaging for filling materials containing harmful substances
- Reusable packaging

According to the law, we are obliged to take back used, completely emptied packaging of the same type, shape and size as placed on the market by us free of charge at the place of actual handover or in its immediate vicinity. In case you are not a private end user, different agreements that we have made with you for the return of packaging take precedence.

In accordance with the law of introducing, returning and high-quality recycling of packaging (packaging act - VerpackG), all packaging placed on the market by Xomox International GmbH & Co. OHG are disposable through our disposal partner:
